The Army has determined that no further munitions response is necessary for two areas in the northeast portion of East Garrison: Area 2 (114 acres) and Area 4 Northeast (63 acres). A document titled "Track 1 Plug-In Approval Memorandum East Garrison Areas 2 and 4 NE Former Fort Ord, California" (March 2006) describes the rationale for taking no further munitions response in these areas of the former Fort Ord.

Track 1 sites are sites suspected to have been used for military training with military munitions but no further response action is required based on remedial investigation. Investigations of the East Garrison Areas 2 and 4 NE identified evidence of past training involving military munitions. Training at East Garrison Areas 2 and 4 NE involved only the use of practice and pyrotechnic items that are not designed to cause injury. In the unlikely event that a like item of the type previously observed in the area is found, it is not expected that the item would function by casual contact (i.e. inadvertent and unintentional contact).

Consistent with the Track 1 plug-in process, the Approval Memorandum was made available for a 30-day public review period that ended on April 28, 2006. The Army received a public comment and responded to the commenter. The Army has received concurrence from the U.S. Environmental Protection Agency and the State of California, Department of Toxic Substances Control on this decision document. The Track 1 plug-in process is now complete for East Garrison Areas 2 and 4NE.
