Enclosed for your information is a revised schedule for submitting primary documents under the Fort Ord Federal Facility Agreement (1990 FFA) pertaining to timetables and schedules for the Military Munitions Response Program (MMRP). Under Track 2 Del Rey Oaks Remedial Design/Remedial Action (RD/RA) program, the draft RD/RA work plan was issued on April 28, 2010. The Army received comments from U.S. Environmental Protection Agency (EPA) and the public. The EPA comments were discussed by the Fort Ord Munitions Response Base Realignment and Closure (BRAC) Cleanup Team (BCT) and the reuser in a meeting on June 24, 2010. During the June 25, 2010 monthly meeting, the BCT agreed to extend the FFA schedule to accommodate the time required to incorporate the results of the comment resolution meeting in the draft final version of the document.
